

# DE International schedule of visa subclasses and enrolment conditions

Visa type	Notes
<b>Permanent Resident (PR)</b>	<p>Fees cannot be charged. The student/parents are required to apply for enrolment directly to their local state school.</p> <p>NOTE:</p> <ul style="list-style-type: none"> <li>• A permanent resident will have a visa grant notification that indicates that the holder is permitted to remain in Australia indefinitely.</li> <li>• <a href="#">Guidelines for assessing parental linkage between a child and an Australian citizen or permanent resident</a> are used by the Department of Education International (DEi) to assess if the temporary resident applying for enrolment at a State school is the child of an Australian citizen or permanent resident, and if the child's enrolment is free under the <i>Education General Provisions Act 2006</i> (Qld) (EGPA).</li> </ul>
<b>Temporary Resident (T)</b>	<p>Temporary visa holders who are required to pay fees must obtain an 'Authority to enrol in a state school' from the Department of Education International (DEi).</p> <p>Fees may be charged in accordance with s51(3) of the EGPA.</p> <p>If fees are not charged there must be:</p> <ul style="list-style-type: none"> <li>• an exemption in line with s51(6)(a) of the EGPA; or</li> <li>• a waiver (s51(6)(b)).</li> </ul>
